**TEAKAI TEIOKI (EXERCISE OF**  
**PREROGATIVE OF MERCY) ORDER 2009**  
Section 50 (a) , Constitution

Whereas on the third day of December, 2001 Teakai Teioki was convicted in the High Court of Kiribati of the murder of Tamaiti Tiaoti and was sentenced to imprisonment for life;

In exercise of the powers conferred upon me by section 50(a) of the *Constitution*, acting accordance with the advice of the Cabinet, to mark the occasion of the 30<sup>th</sup> Anniversary of the Independence of the Republic of Kiribati, I hereby grant a pardon to the said Teakai Teioki in respect of the said conviction, thereby pardoning, remitting and releasing unto him all pains, penalties and punishments whatsoever that may ensue from the said conviction;

The grant of the said pardon is subject to the condition that, for a period of five years from this day, the said Teakai Teioki shall keep the peace and not commit any offence punishable by law, failing which the said pardon shall be revoked and he shall be returned to prison to serve the balance of his sentence;

And I command and require the Superintendent of Prisons and all others whom it may concern to give effect to the said pardon.

**PREROGATIVE OF MERCY) ORDER 2009**

Secretary 50 (a), Constitution

Whereas on the twenty-third day of April, 2008 Bateriki Teboata was convicted in the High Court of Kiribati of the murder of Katerine Totongo and was sentenced to imprisonment for life;

In exercise of the powers conferred upon me by section 50(a) of the *Constitution*, acting in accordance with the advice of the Cabinet, to mark the occasion of the 30<sup>th</sup> Anniversary of the Independence of the Republic of Kiribati, I hereby grant a pardon to the said Bateriki Tebotoa in respect of the said conviction, thereby pardoning, remitting and releasing unto him all pains, penalties and punishments whatsoever that may ensue from the said conviction;

The grant of the said pardon is subject to the condition that, for a period of five years from this day, the said Bateriki Tebotoa shall keep the peace and not commit any offence punishable by law, failing which the said pardon shall be revoked and he shall be returned to prison to serve the balance of his sentence;

And I command and require the Superintendent of Prisons and all others whom it may concern to give effect to the said pardon.

REPUBLIC OF KIRIBATI  
TEKIERA MWEMWENIKEAKI (EXERCISE OF  
PREROGATIVE OF MERCY) ORDER 2009

Section 50(d), constitution

Whereas on the tenth day of December, 2008 Tekiera Mwemwenikeaki was convicted in the High Court of Kiribati of four offences of embezzlement and was sentenced to imprisonment for 15 months;

In exercise of the powers conferred upon me by section 50(d) of the Constitution, acting in accordance with the advice of the Cabinet, to mark the occasion of the 30<sup>th</sup> Anniversary of the Independence of the Republic of Kiribati, I hereby remit all the remaining period of the said sentence of imprisonment imposed upon the said Tekiera Mwemwenikeaki in respect of the said conviction, thereby rendering him eligible for immediate release from custody;

And I command and require the Superintendent of Prisons and all others whom it may concern to give effect to the said remission.

Section 50(a), Constitution

Whereas on the twenty-eighth day of September, 2007 Toota Metai was convicted in the High Court of Kiribati of the murder of Burete Tom and was sentenced to imprisonment for life.

In exercise of the powers conferred upon me by section 50(a) of the Constitution, acting in accordance with the advice of the Cabinet, to mark the occasion of the 30<sup>th</sup> Anniversary of the Independence of the Republic of Kiribati, I hereby grant a pardon to the said Toota Metai in respect of the said conviction, thereby pardoning, remitting and releasing unto her all pains penalties and punishments whatsoever that may ensue from the said conviction.

The grant of the said pardon is subject to the condition that, for a period of five years from this day, the said Toota Metai shall keep the peace not commit any offence punishable by law, failing which the said pardon shall be revoked and she shall be returned to prison to serve the balance of her sentence.

And I command and require the Superintendent of Prisons and all others whom it may concern to give effect to the said pardon.
