**AUR ATOLL DEVELOPMENT AUTHORITY  
(AMENDMENT) ACT 2025**

**AN ACT** to amend the Aur Development Authority Act to restructure the composition of the Board of Directors, ensure representation of key stakeholders and enhance the government and management of the Authority for the sustainable development and welfare of the people of Aur.

**BE IT ENACTED BY THE NITIJELA OF THE REPUBLIC OF THE MARSHALL ISLANDS**

**§101. Short title.**

This Act may be cited as the Aur Atoll Development Authority (Amendment) Act 2025.

**§102. Amendment.**

*Section 307 of the Act is hereby amended to increase the current membership of the board from five (5) to seven (7).*

**§307. Organization and Management.**

- (1) The powers and duties of the Authority are hereby vested in and shall be exercised by the Board. The Board shall consist of five (5) members as follows:
- (a) Senator elected to represent the Aur Atoll in the Nitijela;
  - (b) The Mayor of the Aur Atoll Local Government
  - (c) Two (2) members representing Aur Atoll Iroj;

- (d) Two (2) members each representing Alabs, one from Aur and one from Tobal;
- (e) One member representing the community at-large who shall be selected by the Board.

**§103. Effective Date.**

This Chapter shall take effect on the date of certification in accordance with Article IV, Section 21 of the constitution.




