**JALUIT ATOLL ECONOMIC DEVELOPMENT  
AUTHORITY (AMENDMENT) ACT 2025**

**AN ACT** to amend the Jaluit Atoll Economic Development Authority Act to increase the membership of the Board of the Authority to include an additional Senator representing Jaluit Atoll and for other related purposes.

**BE IT ENACTED BY THE NITIJELA OF THE REPUBLIC OF THE MARSHALL ISLANDS**

**§101. Short title.**

This Act may be cited as the Jaluit Atoll Economic Development Authority (Amendment) Act 2025.

**§102. Amendment.**

**1506. Organization and Management.**

- (1) The powers and duties of the Authority are hereby vested in and shall be exercised by the Board shall consist of eleven (11) members appointed by the President from the offices and nominations as follows:
  - (a) two Senator representing Jaluit Atoll in the Nitijela;
  - (b) the Mayor of the Jaluit Atoll Local Government or a member of the Council nominated by the Mayor;
  - (c) the President of the Jaluit Atoll Chamber of Commerce, and until the establishment or formation of such Chamber of Commerce, a

representative nominated by consensus of the Jaluit Atoll business community;

- (d) four (4) Iroijlaplap or designees representing each of the four (4) domains from the Ralik Chain who are the principal landowners of Jaluit Atoll.
- (e) One (1) member to be appointed by the four (4) domains from the Ralik Chain representing all alaps on Jaluit Atoll;
- (f) two (2) members to be nominated by a majority of the Board appointed under Subsection 1 (a), (b), (c), (d), and (e) above. In the event the Board is unable to nominate such two (2) members, the President of the Marshall Islands shall appoint such members from among those person considered for nomination by the Board.

**§103. Effective Date.**

This Act shall take effect on the date of certification in accordance with Article IV, Section 21 of the constitution.


