To amend the Marshall Islands Airports Authority Act of 1999, Sections 3.1 (1), 3.8 (1) and 3.11 to, among other things, increase the membership of the Authority's Board of Directors from five (5) to seven (7).

BE IT ENACTED BY THE NITIJELA OF THE MARSHALL ISLANDS:

Section 1. **Short Title.**

7

This Act may be cited as the Marshall Islands Airports Authority (Amendment) Act, 2000.

Section 2. **Amendment.**

10

The Marshall Islands Airports Authority Act of 1999, P.L. 1999-86, is hereby amended as follows:

(A) By re-wording Section 3.1 (1) to read as follows:

13

“(1) The Board is to consist of 7 members as follows:

14

(a) the person for the time being holding the position of the Secretary for

15

Transportation and Communication;

16

(b) 3 persons representing relevant public or government sector agencies; and

(c) 3 private sector members.”

(B) By amending the first line of Section 3. 1 (2) to read as follows:

“(2) The private sector members and the members referred to in Subsection (1) (b)

of Section 3.1.”

5 (C) By amending Section 3.1 (3) to read as follows:

6 “(3) The Minister must appoint one of the members of the Board as Chairperson  
7 of the Board.”;

8 (D) By amending Section 3.8 (1) of the Act to read as follows:

9 “(1) The Minister may attend meetings of the Board as necessary and take part in  
10 discussions at those meetings. However, the Minister may not be present when matters are  
11 voted on.”; and

12 (E) By amending Section 3.11 (1) to read as follows:

13 “(1) At a meeting of the Board, 5 members constitute a quorum.”

14  
15 Section 3. Effective Date.

16 This Act shall take effect on the date of certification in accordance with Article 1V,  
17 Section 21 of the Constitution.


