

 - any money appropriated by the Nitijela for the purposes of the Fund; (1)(2)
 - all fees, fines, and other sums paid to and collected by the courts for or with respect to the violation of National Government laws, except such sums as may be paid to Local Government Councils under the Judiciary Fund Act of 1989 (27 MIRC 1A), and except as otherwise provided for by any other Act; and
 - all grants, and gifts, received by the Ministry of Justice, other than money
