1 to amend section 203 of the Non-Resident Workers Fee Act, 16 MIRC Ch. 2 (the Act) to
2 restore the original subsections (2) and (3) of that section that were inadvertently repealed in
3 PL1996-9.

6 **BE IT ENACTED BY THE NITIJELA OF THE MARSHALL ISLANDS**

9 **Section 1. Short Title**

10 This Act may be cited as the Non-Resident Workers Fee (Amendment) Act, 2004.

11 **Section 2. Amendments**

12 Section 203 is amended to read as follows;

13 **§203. Fee to be charged from Employers of Non-resident Workers.**

14 (1) Every employer of a non-resident worker shall pay to the Secretary a fee of a
15 quarter dollar (\$0.25) for every hour of work performed by such non-resident worker for
16 such employer. The payment of this fee shall also apply to an employer who receives any
17 remuneration in such position and who is not a citizen of the Republic. The Cabinet may
18 exempt an employer of an non-resident worker from the fee in qualified export oriented
19 projects. This exemption shall apply only to qualified export oriented projects
20 commenced after the date of certification of this Act.

1 be for a period of not less than forty (40) hours per week, whether the non-resident
2 worker performs work or not, except in special circumstances where the job requires less
3 than forty (40) hours per week and is so stated in the labor contract filed with respect to
4 such non-resident worker in the Division of Labor in the Ministry of Foreign Affairs.

5 (3) The payment due under subsection (1) of this section shall be made on a
6 quarterly basis calculated to the last day of the months of March, June, September and
7 December each year.

8 Section 3. **Effective Date**

9 This Act shall take effect upon certification in accordance with Article IV Section
10 21 of the Constitution and the Rules of Procedure of the Nitijela.


