**PUBLIC SERVICE COMMISSION COMPENSATION  
(AMENDMENT) ACT, 2025**

**AN ACT** to amend Title 5 of the MIRC Chp. 2, to properly adjust salaries for the Members of the Public Service Commission.

**BE IT ENACTED BY THE NITIJELA OF THE REPUBLIC OF THE MARSHALL ISLANDS**

**§101. Short title.**

This Act may be cited as the Public Service Commission Compensation (Amendment) Act, 2025.

**§102. Amendment.**

Section 202 of the Public Service Commission Compensation Act of 1983 is amended to which it shall read as follow:

**§202. Public Service Commission compensation.**

The Chairman and members of the Public Service Commission shall receive their salaries as follows:

- (a) the Chairman of the Public Service Commission shall receive a salary of \$45,000 per annum; and
- (b) the members of the Public Service Commission shall receive a salary of \$43,000 per annum; and
- (c) the Chairman and members of the Public Service Commission shall be entitled to other benefits normally

accorded by employees of the Public Service, except for annual and sick leave.

**§103. Effective date.**

This Act shall take effect on the date of certification in accordance with Article IV, Section 21 of the Constitution and the Rules of Procedures of the Nitijela.
