**REPUBLIC OF THE MARSHALL ISLANDS MARITIME
ZONES DECLARATION (AMENDMENT) ACT, 2025**

AN ACT to amend Section 118 of the Maritime Zones Declaration Act 2016 to provide that the established geographic coordinates for the baseline and maritime zone outer limits of the Republic of the Marshall Islands shall not be reduced notwithstanding physical changes to the coastline connected to climate change-related sea-level rise.

BE IT ENACTED BY THE NITIJELA OF THE REPUBLIC OF THE MARSHALL ISLANDS

§101. Short title.

This Act may be cited as the Republic of the Marshall Islands Maritime Zones Declaration (Amendment) Act, 2025.

§102. Amendment

- (1) Section 118 of the Maritime Zones Declaration Act is amended by inserting immediately after subsection (2) the following new paragraph, to read as follows:

§118. Declarations and official charts

- (3) The baselines and maritime zone outer limits of the Republic of the Marshall Islands as recorded in the geographic coordinates prescribed in declarations made under section 118(1) and deposited with the United Nations, shall not be reduced notwithstanding physical changes to the coastline connected to climate change-related sea level-rise.

§103. Effective Date

This Act shall take effect in accordance with the Constitution and the Rules of Procedure for the Nitijela.
