14 grant by the Republic of China, of a total sum of \$19,979,783 to
15 meet the supplementary special appropriations and capital
16 expenditures of the Government for the Financial Year 2000, and
17 to appropriate sums to program areas, and for related purposes
18 as directed by Cabinet; and

20 (b) for a Contingencies Fund in accordance with Section 9
21 of Article VIII of the Constitution; and

24 of Article VIII of the Constitution; and

30 BE IT ENACTED BY THE NITIJELA OF THE MARSHALL ISLANDS:

31 Section 1. Short Title and Effective Date.

32 This Act may be cited as the Supplemental Appropriation
33 (Financial Year 2000) Act, 2000.

5 Section 2. Statement of National Objective.

6 It is the intention of the Government of the Republic
7 of the Marshall Islands to hereby enact and implement a
8 supplementary budget to authorize necessary and desirable
9 expenditure over and above that authorized by the
10 Appropriations (Financial year 2000) Act, 2000, P.L. 2000-
11 2, to meet the supplementary special appropriations and
12 capital expenditures incurred in the program areas
13 categorized and set out in Schedule 1, and as summarized in
14 Schedule 3.

15 Section 3. Interpretation.

16 In this Act -

17 (1) "program area" means program areas set out in
18 Schedule 1 as indicated by numbering in the first column of
19 the Schedule, and summarized in Schedule 3.

Section 4. Appropriation from the Marshall Islands
General Fund.

The total sum of \$27,979,783 (being the total of bank loans and grant from the Republic of China received by the Government of the Republic of the Marshall Islands, as set out in Schedules 2 and 4) is hereby appropriated and may be withdrawn from the Marshall Islands General Fund pursuant to Article VIII of the Constitution, for the program areas as set out in Schedule 1, Special Appropriations and Capital Expenditures, the Contingencies Fund and other expenditures contingent upon the determination of actual liabilities in various matters, including litigations, the health fund and other allied prospective liabilities, and for related purposes as directed by Cabinet during the Financial year.

Section 5. Lapsing of Funds

The appropriation made under Section 4 shall not lapse at the end of the Financial year but shall continue until either

(a) the purposes of the appropriation are satisfied, or (b) the funds are expended, whichever occurs first.

5 **Section 6. Delegation of Authority.**

6 (1) For the purpose of Article VIII, Section 5(1) of
7 the Constitution, the authority to approve expenditure in a
8 program area in accordance with Schedule 1, is hereby
9 delegated to:-

10 (a) the member of Cabinet primarily responsible
11 for that program area; and

12 (b) if the responsible member of Cabinet so
13 directs by instrument in writing, and subject to any
14 limitations imposed by the instrument and to general
15 control by the member, the appropriate person, authority,
16 or agency, subject in either case to any limitations
17 imposed by the Cabinet.

18 (2) Any expenditure otherwise than in accordance with
19 Schedule 1 shall require the approval of the Cabinet in
20 accordance with Article VIII, Section 5(1) of the
21 Constitution.

22 **Section 7. Budget Estimates.**

23 Budget estimates for expenditure and revenue are set
24 forth in Schedules 1 and 2, and summarized in Schedules 3
25 and 4 hereto, respectively, provided that:

7 in accordance with Regulations to be approved by the

10 Section 8. Effective Date.

11 This Act shall come into effect on the date of
12 certification in accordance with Article IV, Section 21 of
13 the Constitution.
