

To issue and apply out of Public Moneys a sum for the service of the remainder of the year that ends on the thirtieth day of June, One thousand nine hundred and sixty-six, and to appropriate that sum.

I, the Administrator of the Island of Nauru, in pursuance of the powers conferred by Article I of the Agreement dated the second day of July, 1919, between the Government of the United Kingdom, the Government of the Commonwealth of Australia and the Government of New Zealand, hereby make the following Ordinance.

APPROPRIATION ORDINANCE 1966

Short title.

1. This Ordinance may be cited as the

Appropriation Ordinance 1966.

Applica-  
tion.

2. There may be issued and applied out of Public Moneys of the Territory for the service of the remainder of the financial year that ends on the thirtieth day of June, One thousand nine hundred and sixty-six, for each of the purposes set forth in the Schedule to this Ordinance such sum, which when added to the sum already expended in that financial year before the commencement of this Ordinance for that purpose, does not exceed the sum specified in that Schedule in relation to that purpose.

3. The sums to be issued and applied under the last preceding section are hereby appropriated

accordingly.

4. Subject to the consent of the Minister, the Administrator may out of moneys appropriated under this Ordinance authorize the expenditure of an amount -

- (a) on an Administration service not specified in the Schedule to this Ordinance; or
- (b) on an Administration service specified in the Schedule to this Ordinance in excess of the amount specified in that Schedule in respect of that service.

5. Nothing in this Ordinance authorizes the Administrator to expend in the remainder of the financial year that ends on the thirtieth day of June, One thousand nine hundred and sixty-six, sums which, when added to sums already expended in that financial year before the commencement of this Ordinance, exceed One million, seventy-three thousand, four hundred and seven pounds.
