Enacted by the Parliament of Nauru as follows:

1 Short title

This Act may be cited as the Constitution (Amendment) Act 2021.

2 Commencement

This Act commences on certification by the Speaker.

3 Amendment of the Constitution of Nauru 1968

The Constitution of Nauru 1968 is amended by the provisions of this Act.

4 Amendment of Article 49

Subarticle (3) is amended by deleting 'five' and substituting with '10'.

5 Amendment of Article 57

Article 57 is amended:

- (a) in subarticle (1), by:
 - (i) deleting the word 'all'; and
 - (ii) inserting the words 'or as prescribed by law' after 'the Supreme Court';
- (b) by deleting and substituting subarticle (3) as follows:
 - '(3) There shall be a President of the Nauru Court of Appeal, who shall be appointed by the President.'.
- (c) by deleting and substituting subarticle (4) as follows:
 - '(4) The Nauru Court of Appeal shall consist of the President of the Nauru Court of Appeal and such other number of Justices of Appeal as may be prescribed by law.'.
- (d) by deleting and substituting subarticle (5) as follows:
 - '(5) The Justices of Appeal are to be appointed by the President in consultation with the President of the Nauru Court of Appeal.'.
- (e) by deleting subarticle (6);
- (f) by re-numbering subarticles (7), (8), (9) and (10) as subarticles '(6), (7), (8) and (9)'; and
- (g) in the new subarticle (6), by deleting '5' and substituting with '10'.

6 Amendment of Article 69

Article 69 is amended:

- (a) in subarticle (2)(a), by deleting the words 'the Chief Justice' and substituting with 'a person qualified to be appointed as a Judge of the Supreme Court to be appointed by the Cabinet,'; and
- (b) by inserting a new subarticle (2A) as follows:
 - '(2A) The appointment of the Chairman of the Police Service Board shall be for a continuous period of 3 years and is eligible to be re-appointed.'.

7 Amendment of Article 70

Article 70 is amended as follows:

- (a) in subarticle (1), by deleting the words 'the Chief Justice' and substituting with 'a person qualified to be appointed as a Judge of the Supreme Court to be appointed by the Cabinet';
- (b) by inserting a new subarticle (2A) as follows:
 - '(2A) The appointment of the Chairman of the Public Service Appeals Board shall be for a continuous period of 3 years and is eligible to be re-appointed.'; and
- (c) in subarticles (4) and (5), by deleting the words 'Chief Justice' and substituting with 'Chairman'.
