

AN ACT

Be it enacted by the Parliament of Nauru as follows:-

- 
- Short Title. 1. This Act may be cited as the Nauru Housing Fund Supply Act 1968-1969.
- Termination. 2. This Act ceases to have effect on the first day of October, 1968, or upon the coming into operation of an appropriation law in respect to the Nauru Housing Fund for the financial year ending on the thirtieth day of June, 1969.
- Withdrawal of Money from the Nauru Housing Fund. 3. The amount of One hundred and twenty two thousand six hundred dollars may be withdrawn from the Nauru Housing Fund and expended for the erection, repair, and maintenance of houses in Nauru in the manner specified in the Schedule of the Act.
