To make interim provision for the withdrawal and expenditure of moneys from the Treasury Fund and the Nauru Housing Fund in payment for goods and services obtained or ordered for the Republic during the first quarter of the financial year ending on the thirtieth day of June, One Thousand Nine Hundred and Ninety Four.

Be it Enacted by the Parliament of Nauru as follows:

SHORT TITLE

1. This Act may be cited as the Supply Act 1993.

COMMENCEMENT AND EXPIRY

2. This Act shall come into force on the first day of July, One Thousand Nine Hundred and Ninety Three and shall cease to have effect on the first day of October, One Thousand Nine Hundred and Ninety Three, or upon the coming into operation of the appropriation law in respect of the financial year ending on the thirtieth day of June, One Thousand Nine Hundred and Ninety Four, whichever is the earlier.

WITHDRAWAL OF MONEYS FROM THE TREASURY FUND

3. The amount of Twenty Two Million Six Hundred and Seventeen Thousand Five Hundred Dollars only (\$22,617,500) may be withdrawn from the Treasury Fund and expended as authorized in the Schedule to this Act, in payment for goods and services obtained or ordered for the Republic until this Act shall cease to have effect in accordance with Section 2.

NAURU HOUSING FUND

4. Where moneys are withdrawn from the Treasury Fund and expended as authorized in the Schedule to this Act for the erection, maintenance and repair of Nauruan housing, the Treasury Fund shall be reimbursed from the Nauru Housing Fund to the extent of that expenditure and the Nauru Housing Fund is hereby charged accordingly.

INCOME FROM NAURUAN HOUSING

All deposits, purchase moneys, rentals, interest and other moneys paid in respect of the erection, maintenance or repair of housing provided Nauruan in accordance with the expenditure by Section 4 or the disposal of any assets acquired authorized connection therewith, shall be paid to the Nauru Housing Fund.
