  - (2) THE AMOUNT AUTHORISED BY THIS SECTION TO BE WITHDRAWN FROM THE TREASURY FUND AND EXPENDED IS ADDITIONAL TO AND NOT IN SUBSTITUTION FOR THE AMOUNTS AUTHORISED TO BE WITHDRAWN FROM THE TREASURY FUND AND EXPENDED BY THE APPROPRIATION ACT 1998-99
