The Cabinet makes the following Regulations under Section 32 of the Naoero Citizenship Act 2017:

1 Citation

These Regulations may be cited as the *Naoero Citizenship (Forms and Fees)* (Amendment) Regulations 2021.

2 Commencement

These Regulations commence on the day they are notified in the Gazette.

3 Amendment of Naoero Citizenship (Forms and Fees) Regulations 2019

The Naoero Citizenship (Forms and Fees) Regulations 2019 is amended by these Regulations.

4 Amendment of Regulation 5

Regulation 5 is amended as follows:

- (a) for subparagraph (d), by deleting the word 'or' after the semicolon;
- (b) for subparagraph (e), by:
 - (i) deleting the full stop and inserting a semicolon after 'Schedule 2'; and
 - (ii) inserting the word 'or' after the semicolon; and
- (c) inserting a new subparagraph (f):
 - '(f) by a parent or parents of a minor or dependent under Section 19A of the Act, shall be in Form 8 of Schedule 2.'

5 Amendment of Regulation 6

Regulation 6 is amended by inserting a new subregulation (5) as follows:

- '(5) For the purpose of an application for citizenship under Section 19A of the Act, the applicant shall provide:
 - (a) full name of minor or dependent;
 - (b) original or certified true copy of the original birth certificate of the minor or dependent;
 - (c) evidence that one or both parents are citizens;
 - (d) original or certified true copy of the applicant's birth certificate; and
 - (e) evidence that the minor or dependent is present in the Republic; or

(f) evidence that the dependent is wholly dependent on the applicant.

6 Amendment of Schedule 2

Schedule 2 is amended by inserting a new Form 8 as follows:
