PUBLIC SERVICE ACT 1961-1971

HOURS OF ATTENDANCE

(SECTION 39 (4))

DETERMINATION OF THE PUBLIC SERVICE COMMISSIONER WITH RESPECT TO OFFICERS AND EMPLOYEES EMPLOYED ON THE AIRPORT PROJECT OF NAURU.

In accordance with the powers conferred upon me and by virtue of Section 39 Subsection (4) of the Public Service Act 1961-1971, I determine:-

- (i) That the hours of duty for officers and employees employed on the Airport project of Nauru shall be worked between the hours of twelve midnight and twelve midnight of the following day, Monday to Saturday, inclusive.
- (ii) That no officer or employee, engaged on such shift work shall exceed a total of forty hours in any one week without the payment of overtime.
- (iii) That the effective date of the introduction of the aforesaid hours of duty will be Monday Thirteenth December, 1971.
