NOTICE OF REVOCATION

AND DETERMINATION

GN No. 190/1972 is revoked and the following determination stands in lieu thereof:

Land Appeal No. 1 1972

BETWEEN:

and

Respondent

WHEREAS the above appeal came before the Supreme Court on 17th April, 1972 in respect of the Nauru Lands Committee's determination of the 14th March, 1972 (GN No. 71/1972).

AND WHEREAS the judgment of the Court was that the matter be referred back to the Committee with the following questions:

- (a) whether a Will of Sarah Enga has ever been proved before the Committee;
- (b) whether a family meeting has ever been held to discuss distribution of Sarah Enga's estate; and
- (c) whether any determination of the general distribution of her estate has ever been made by the Committee;

AND WHEREAS the Lands Committee has found that the answers to each of the questions (a), (b) and (c) are as follows:

- (a) No
- (b) No
- (c) Yes

The Committee having made all due enquiry does hereby determine that the phosphate land portion No. 99 "ORMANGANG" in Ewa District was not and never has been the property of Sarah Enga and that the said land formed part of the estate of the late Adedea and has not been distributed.

Any person who wishes to appeal against this determination must lodge an appeal to the Supreme Court Registry within 21 days of this Gazette.
