Against a determination of the Nauru Lands Committee in respect of land Iyeida portion 21 phosphate land in Anetan District as published in Gazette No. 28 of 1972.

The 15th day of September, 1972.
Mr. Justice I.R. Thompson, Chief Justice.

Appeal allowed. Determination of the Nauru Lands Committee in respect of portion 21 set aside. The land is called alternatively Botibab or Iyeida and was owned by Dekeka and Arari. Persons now entitled to be registered as owners are those entitled to inherit the estates of Dekeka and Arari. If distribution of those estates already decided the details of the present owners to be registered forthwith. If not, the distribution is to be decided and until then the owners to be recorded as "the persons entitled to the estates of Dekeka and Arari".
