FORMER GERMAN WIRELESS STATION LANDS

Whereas by Gazette numbered 17 of 6th May 1961 under GN.83/1961 a Committee was appointed to investigate claims referred to it by the Administrator from any person who claimed to be entitled to participate in the distribution of a sum of money equal to all moneys that have been received by the Administration as surface rights or phosphate royalties in respect of the working of the Former German Wireless Station Lands for phosphate.

I, REGINALD SYLVESTER LEYDIN, the Administrator of the Island of Nauru, pursuant to Section 4 of the Land (Declaration of Ownership) Ordinance 1962 and all other powers me thereunto enabling, publish hereunder the recommendations of the said Committee. Any person who is dissatisfied with the Committee recommendations may lodge his objection with the Administrator within 21 days of the publication of this notice. Any such objection will be referred to the Committee for advice to the Administrator whose decision on the objection will be final.

Failing the receipt of any objection within the prescribed time distribution of a sum of money equal to all moneys that have been received by the Administration before the 14th May 1962 or that are received by the Administration on or after that date as surface rights or phosphate royalties in respect of the working of the land for phosphate will be made in accordance with the recommendations of the Committee.
