NAURU PUBLIC SERVICEVACANCY

Applications are called for candidates to undertake a training course for Air Hostesses in Australia and Nauru. Applications should be forwarded to the Public Service Commissioner at the Chief Secretary's office, Administration Building, and must be received not later than 4.30 p.m. on Tuesday, 23rd April, 1974.

Applicants:

- 1) must be over 18 years;
- 2) under 9 stone in weight;
- 3) must forward information on educational standard and present employment, and

Present members of the Public Service will be given consideration to attend the training course.

The Public Service Commissioner wishes to make it clear that applicants chosen for the course do not necessarily thereby gain employment in the Public Service. The candidates who undertake a successful course, however, will be considered for future service in Air Nauru either on a permanent or relief basis.

Appropriate allowance will be paid for attendance at the Air Hostess Training Course in Australia.

Successful applicants will be paid a commencing salary as follows:
