

APPOINTMENT BY CABINET UNDER ARTICLE 21

ASSIGNMENT OF RESPONSIBILITIES UNDER ARTICLE 23

The Portfolios of Health and Education, Justice, External Affairs and Internal Affairs.

Minister for Works and Community Services

The portfolio of Island Development and Industry.

The above assignments of responsibility for the business of the Government of Nauru shall be effective during the absence from the Republic of His Excellency President Hammer DeRoburt, O.B.E., M.P. and the Honourable Joseph Detsimea Audoa, M.P.
