## REGISTER OF RELIEVING TEACHERS ASSISTANTS

- (e) Teaching experience, if any.

The Director of Education will arrange for applicants to be interviewed and to discuss the class level at which they will best be able to assist. He will keep a register of persons who can be called upon at short notice to help out in Infants Schools.
