NAURU PHOSPHATE ROYALTIES TRUST ORDINANCE 1968

By virtue of the provisions of Section 39(2)(c) of the above Ordinance I am required to publish or cause to be published a summary of the Annual Report of the Nauru Phosphate Royalties Trust in the Government Gazette.

I append below a summary of the Nauru Phosphate Royalties Trust Report dated 18th August, 1976 for the financial year ended 30th June, 1976.

1. Trustees

In the year under review membership of the Trust was as follows:

- Mr. T. W. Star, Chairman
- Mr. R. S. Leydin, C.B.E., Deputy Chairman (reappointed a member and acting as Chairman from 4th June for a period of three years).
- Mr. C. E. Reseigh
- Mr. I. D. Dedogi
- Mr. M. R. S. Mitchell (acted as member up until 15th October, 1975 during Mr. Dedogi's absence).

2. Funds Administered by the Trust

In accordance with the provisions of Section 18 and 19 of the Ordinance the Long Term Investment Fund and the Nauru Landowners Royalties Trust Fund are administered by the Trust and in addition certain other funds being the Nauru Rehabilitation Fund and the Nauru Housing Fund are administered by the Trust pursuant to Section 20 of the Ordinance.

3. Investment Policy

The Trust has continued to invest available funds in the manner prescribed by Section 25 of the Ordinance as follows:

- (a) in securities of, or guaranteed by, the Commonwealth or the States of Australia.
- (b) in such other securities or classes of securities as Cabinet has approved.
- (c) on fixed deposit in a Bank approved by the Cabinet, and,
- (d) in such other manner as Cabinet has approved.

In the period under review the Trust has been authorised by Cabinet to invest moneys:-

- (a) for short terms with authorised dealers on the Australian Official short term money market and the Republic of Nauru Finance Corporation.
- (b) in Bills of Exchange accepted or endorsed by an Australian Bank.
- (c) by way of call or fixed deposit for periods of up to 12 months with any Bank in Australia or wholly owned subsidiary of any such Bank, the names of which have been first submitted to and approved by Cabinet, with a maximum of \$3 million with any one Bank or wholly owned subsidiary.
- (d) by way of loans of up to \$3 million against the security of Commonwealth of Australia Government securities or Bank endorsed or accepted Bills of Exchange or Bank Certificates of Deposit issued by approved Banks to nominated and Cabinet approved Merchant Banks.
- (e) by way of call or fixed deposit for periods of up to 12 months with the Nauru Branch of the Bank of New South Wales.
- (f) in equities quoted on Australian Stock Exchanges or recognised overseas Stock Exchanges.
- (g) in first charge Company debentures quoted on an Australian Stock Exchange or recognised overseas Stock Exchanged.
- (h) in first charge company debentures not quoted on an Australian Stock Exchange provided that the total amount invested in any one Fund in such non-quoted debentures does not exceed 25% of the total amount invested in first charge Company debentures.
- (i) in registered first mortgages over freehold estate in an amount not exceeding \$1 million in any one transaction and subject to the conditions laid down in the Trustees Act 1958 of Victoria.
- (j) in suburban house properties in Melbourne and its environs in an amount not exceeding \$100,000 in all.

4. Securities Lodged with Third Parties as Collateral for Loans to the Republic of Nauru Finance Corporation (Ronfin)

In accordance with Cabinet's directions issued under Section 30 of the Republic of Nauru Finance Corporation Act 1972 securities to the value of \$7,858,433 have been lodged with the Bank of America National Trust and Savings Association with the Bank of New South Wales as collateral for loans made by

these Banks to Ronfin. Further, in accordance with the provisions of the Nauru Local Government Council Guarantee Act 1971 Commonwealth of Australia Government Bonds to a total value of \$1 million have been lodged by the Trust with the Bank of New South Wales as guarantee of the instalment payments by the Nauru Local Government Council on M.V. Kollé D.

5. Loan Investments

During the year under specific Cabinet authorities two loans of \$3 million and \$2 million respectively were made to Ronfin to enable it to finance the construction of the Nauru Phosphate Corporation's calcination plant and so on - lending to the Nauru Local Government Council to provide funds to the Nauru Pacific Line respectively. The total indebtedness of Ronfin to the various Trust funds stood at \$12,699,999 at 30th June, 1976.

6. Debentures

The following percentage of the various funds administered by the Trust were held in non-quoted company debentures at 30th June, 1976:

7. Equity Investments

A sustained equity buying programme has been maintained throughout the year, net investment increasing by \$7,727,170. The equity market in Australia has recovered substantially since the change of Government in December, 1975. Latterly Company interim results have been encouraging and satisfactory annual results are expected during the period under review. The market value of the Trust's equity portfolio when adjusted for new investments showed a capital appreciation of 29.26 per cent.

8. Real Estate

Further progress with the construction of Nauru House has been made during the year, levels 5 - 18 having been ready for occupancy from 21st May, 1975 and Levels 19 - 27 being available for occupation from 28th November, 1975. Construction reached its maximum height of 598 feet on 10th March, 1976. It is expected that the various instrumentalities of the Republic located in Melbourne will move into Nauru House about November, 1976 with the official opening in mid-December. The total amount invested in Nauru House at 30th June, 1976 was \$33,592,217.

9. Audit of the Trust's Accounts

An Audit Certificate without qualifications has been issued by the Director of Audit of the Republic.
