## EXPLANATORY NOTE

(This note does not form a formal part of the above Notice but is inserted by way of informal explanation only).

The effect of this Notice is to bring the above-mentioned Acts into operation so as to allow appeals from the Supreme Court to the High Court of Australia in certain criminal and civil proceedings. However no appeal to the High Court of Australia is allowed -

- (a) In Constitutional matters
- (b) Against a determination as to whether a person is or remains a Member of Parliament.
- (c) Where the Supreme Court's judgement is given by consent.
- (d) Against a judgment, decree or order of the Supreme Court upon an appeal from the Nauru Lands Committee.
- (e) Against an order allowing an extension of time granted by the Supreme Court for appealing.
- (f) Against an order giving unconditional leave to defend.
- (g) Where written law provides that the decision of the Supreme Court is final.
- (h) Against an order absolute for dissolution of marriage in respect of a party who has had opportunity to appeal against the decree nisi but has not done so.
