- (a) a Licensing Inspector;
- (b) the Government Medical Officer; or
- (c) jointly, by three or more persons over the age of twenty-one years.

A person who desires to make an objection at the hearing of an application shall lodge with the Registrar a notice of objection stating his full name and address and the grounds upon which the objection is made and shall serve a copy of the notice upon the applicant within twenty-four hours from the time of lodgement.
