CLOSING OF ROLLS AND NOMINATION OF CANDIDATES
FOR GENERAL ELECTION

I, PETER LIONEL JONES, Returning Officer HEREBY GIVE NOTICE in terms of Section 15 of the Electoral Act 1965-1973

- (a) That by virtue of section 10 of the Electoral Act 1965-1973 the rolls shall close in respect of every constituency in the Republic of Nauru at noon on the 22nd day of October, 1977.
- (b) That by virtue of section 16 of the Electoral Act 1965-1973 nominations of candidates for election as a member of any constituency in the Republic of Nauru shall be accepted not later than noon on the 29th day of October, 1977.

The electoral rolls may be inspected at the Office of Nauruan Affairs, Government Buildings, Yaren District, during normal office hours.
