CONSTITUTION OF NAURU

APPOINTMENT BY CABINET UNDER ARTICLE 21

IN EXERCISE of the powers in that behalf vested in it, under Article 21 of the Constitution of Nauru, CABINET HEREBY APPOINTS THE HONOURABLE BURARO DETUDAMO, being the Minister for Justice and a Member of the Parliament of Nauru, to perform the duties and exercise the functions of the President in Nauru during the period of absence from the Republic of His Excellency President Hammer DeRoburt, O.B.E., M.P.

ASSIGNMENT OF RESPONSIBILITY

FOR BUSINESS OF GOVERNMENT

IN EXERCISE of the powers in that behalf vested in me under Article 23 of the Constitution of Nauru, I, HAMMER DEROBURT, President of the Republic of Nauru, HEREBY ASSIGN to the Ministers of the Cabinet of Nauru as set out below, the responsibilities for the business of the Government of Nauru as set out opposite their names :-

The Portfolio of the Minister for Island
Development and Industry in relation to
the business of Government to be under-
taken in Nauru by the said Minister.

The assignment of the business of the Government of Nauru as set out above
is in addition to and not in substitution for the business of the Government
of Nauru already assigned to the said Minister.

The above assignments of responsibility for the business of Government of
Nauru shall be effective during the absence from the Republic of His
Excellency President Hammer DeRoburt, O.B.E., M.P.

COMMISSIONS OF INQUIRY ORDINANCE 1948-1967
ISSUE OF COMMISSION OF INQUIRY UNDER SECTION 3(1)
OF THE ORDINANCE INTO MATTERS AFFECTING THE
DEPARTMENT OF FINANCE

The Cabinet, IN EXERCISE of its powers under Section 3(1) of the Commissions
of Inquiry Ordinance 1948-1967, HEREBY COMMISSIONS Trevor Gilbert Maxwell
as sole Commissioner to inquire into matters affecting the Department of
Finance with the following terms of reference.

First, to establish what errors of calculation or addition were made by the
Department of Finance in, and in the preparation and compilation of the
Estimates for the financial year 1978/1979;

Secondly, to establish the causes of any such errors;

Thirdly, to establish whether blame for any such errors should be attached
to any person or persons, and the proportion of blame which should be
attached to any such persons;

Fourthly, to advise what steps might be adopted or what system might be
used to avoid any occurrence of any errors in the Estimates for any future
financial year;

Fifthly, to report in detail with reasons for conclusions reached to the Cabinet as soon as may be.

The Cabinet determines that no separate remuneration should be paid to Mr Maxwell in respect of the Commission of Inquiry and leaves to Mr Maxwell's discretion the question of whether or not the inquiry be held in public.
