Duties : Responsible to the Secretary for Finance for the efficient day to day operation of the Republic's computer installation and the supervision of the computer staff. This will include :

The administration of the Computer Bureau with particular emphasis on Budget and Cost Control.

The co-ordination of the overall operation and formulation of policy on the development of computer processing facilities for organisations using the Bureau.

Reviews and reports on the operation, the systems and performance of the EDP function, evaluating the adequacy of the systems and its controls and documentation, both in the development and the ongoing stages.

In consultation with Government Departments and other users of the Bureau, the control of systems application and implementation of base data, not only for EDP but for end users and the development and improvement of accounting and auditing systems, and management reports.

Other such related duties as may from time to time be determined by the Secretary for Finance.

Qualifications and Experience : Ideally applicants should be experienced in the duties of the position including a good working knowledge of systems analysis and programming and have the ability to liaise with potential users and interpret their needs into suitable balanced EDP programmes. Experience in the management of staff and finances within a Government Department and appropriate qualifications would be highly regarded.

AIR HOSTESSES

Applications are invited from young women willing to undergo training as Air Hostesses in Australia and Nauru with a view to employment by Air Nauru. At present nine posts are available. Applications should be forwarded to the Acting Public Service Commissioner (C/- Nauruan Affairs) not later than 4.30 p.m. on Friday, 3rd February 1978.

Applicants must :

- a) be eighteen years of age and over
- b) be under nine stone in weight
- c) supply particulars of their educational standard and present or previous employment

Members of the Public Service are eligible to apply.

Acceptance for training as an Air Hostess does not in itself mean that applicants will be appointed to the Public Service. Those who complete the course successfully will however be eligible for employment by Air Nauru either on a permanent or temporary basis.

While undergoing training in Australia successful applicants will be provided with accommodation and a subsistence allowance. On appointment as Air Hostesses after completion of training they will be paid commencing salaries as follows :

\$2,325 p.a. - 18 years
\$2,713 p.a. - 19 years
\$3,488 p.a. - 20 years
\$3,876 p.a. - Adult
