CONSTITUTION OF NAURU

APPOINTMENT BY CABINET UNDER ARTICLE 21

IN EXERCISE of the powers in that behalf vested in it, under Article 21 of the Constitution of Nauru, CABINET HEREBY APPOINTS THE HONOURABLE BURARO DETUDAMO, M.P. being the Minister for Finance and a Member of the Parliament of Nauru, to perform the duties and exercise the functions of the President in Nauru during the period of absence from the Republic of His Excellency the President Hammer DeRoburt, O.B.E., M.P.

CONSTITUTION OF NAURU

ASSIGNMENT OF RESPONSIBILITY FOR BUSINESS OF GOVERNMENT

(ARTICLE 23)

IN EXERCISE of the powers in that behalf vested in His Excellency The President under Article 23 of the Constitution of Nauru, I, HAMMER DEROBURT, President of the Republic of Nauru, HEREBY ASSIGN to the Ministers of the Cabinet of Nauru as set out below, the responsibilities for the business of the Government of Nauru as set out opposite their names:-

Minister for Finance

Minister for Justice

BUSINESS OF GOVERNMENT

The portfolios of The President, External Affairs, Internal Affairs, and the Public Service in relation to the business of Government to be undertaken in Nauru by the said Minister.

The portfolio of the Minister for Island Development & Industry in relation to the business of Government to be undertaken in Nauru by the said Minister.

The assignment of business of the Government of Nauru as set out above is in addition to and not in substitution for the business of the Government of Nauru already assigned to the said Minister. The above assignments of responsibility for the business of the Government shall be effective during the absence from the Republic of His Excellency President Hammer DeRoburt, O.B.E., M.P.

The above assignment of responsibility for the business of Government of Nauru shall be effective during the absence from the Republic of the Honourable Joseph Detsimea Audoa, M.P., Minister for Health & Education.
