CONSTITUTION OF NAURU

ASSIGNMENT OF RESPONSIBILITY FOR BUSINESS OF GOVERNMENT

(ARTICLE 23)

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN HIS EXCELLENCY THE PRESIDENT UNDER ARTICLE 23 OF THE CONSTITUTION OF NAURU, I BURARO DETUDAMO, BEING THE MINISTER EXERCISING THE FUNCTIONS OF HIS EXCELLENCY THE PRESIDENT IN NAURU UNDER AND BY VIRTUE OF APPOINTMENT AS SUCH BY CABINET UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU HEREBY ASSIGN TO THE MINISTERS OF CABINET OF NAURU AS SET OUT BELOW THE RESPONSIBILITIES OF THE BUSINESS OF THE GOVERNMENT OF NAURU AS SET OUT OPPOSITE THEIR NAMES:

THE ABOVE ASSIGNMENTS OF RESPONSIBILITY FOR THE BUSINESS OF THE GOVERNMENT SHALL BE EFFECTIVE DURING THE ABSENCE FROM THE REPUBLIC OF HIS EXCELLENCY PRESIDENT HAMMER DEROBURT, O.B.E., M.P. AND THE HON L.D. KEKE, M.P., MINISTER FOR JUSTICE.
