PATENTS REGISTRATION (AMENDMENT) (NO. 2) REGULATIONS 1979

TITLE

1. These Regulations may be cited as the Patents Registration (Amendment) (No. 2) Regulations 1979.

THE PRINCIPAL REGULATIONS

2. In these Regulations "the principal Regulations" means the Patents Registration Regulations 1976.

STATUTORY SALARIES ACT 1974

THE CLERK OF PARLIAMENT'S SALARY REGULATIONS 1979

In exercise of the power conferred on it by section 2 of the Statutory Salaries Act 1974, after consultation with the Speaker the Cabinet has made the following regulations -

G.N. No. 221/1979 (Cont'd)

SHORT TITLE

1. These Regulations may be cited as the Clerk of Parliament's Salary Regulations 1979.

SALARY AND ALLOWANCES OF THE CLERK OF PARLIAMENT

- 2. (1) The salary of the Clerk of Parliament shall be whichever amount is the larger of -
 - (a) the amount set out in respect of salary in the Schedule to these Regulations; and
 - (b) the amount which is the sum of that amount and of every amount by which the basic wage of Nauruans is increased after the date on which these Regulations are made.
- (2) The allowances of the Clerk of Parliament shall be those set out in the Schedule to these Regulations.

REPEAL

3. The Clerk of Parliament's Salary Regulations 1976 and the Clerk of Parliament's Salary (Amendment) Regulations 1977 are hereby repealed.
