CONSTITUTION OF NAURU

APPOINTMENT BY CABINET UNDER ARTICLE 21

IN EXERCISE of the powers in that behalf vested in it, under Article 21 of the Constitution of Nauru, CABINET HEREBY APPOINTS THE HONOURABLE BURARO DETUDAMO, M.P., being the Minister for Works and Community Services and a member of the Parliament of Nauru, to perform the duties and exercise the functions of the President in Nauru during the period of absence from the Republic of HIS EXCELLENCY, PRESIDENT HAMMER DEROBURT, O.B.E., M.P.

ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT

The assignment of business of Government of Nauru as set out above is in addition to and not in substitution for the business of the Government of Nauru already assigned to the said Ministers. The above assignments of responsibility for the business of Government shall be effective during the absence from the Republic of His Excellency, President Hammer DeRoburt, O.B.E., M.P., and the Hon L.D. Keke, M.P., Minister for Justice.
