CONSTITUTION OF NAURU  
APPOINTMENT BY CABINET UNDER ARTICLE 21

IN EXERCISE of the powers in that behalf vested in it, under Article 21 of the Constitution of Nauru, CABINET HEREBY APPOINTS THE HONOURABLE JOSEPH DETSIMEA AUDOA, M.P. being the Minister for Health and Education and a member of the Parliament of Nauru, to perform the duties and exercise the functions of the President in Nauru during the period of absence from the Republic of His Excellency President Hammer DeRoburt, O.B.E., M.P.

CONSTITUTION OF NAURU  
ASSIGNMENT OF RESPONSIBILITY FOR BUSINESS  
OF GOVERNMENT

IN EXERCISE of the powers in that behalf vested in His Excellency the President under Article 23 of the Constitution of Nauru, I, HAMMER DEROBURT, President of the Republic of Nauru, hereby assign to the Ministers of the Cabinet of Nauru, set out below, the responsibilities for the business of the Government of Nauru as set out opposite their names:-

Minister for Justice

BUSINESS OF GOVERNMENT

The Portfolio of the Minister for Finance in relation to the business of Government to be undertaken in Nauru by the said Minister.

The assignment of business of Government of Nauru as set out above is in addition to and not in substitution for the business of Government of Nauru already assigned to the said Minister. The above assignments of responsibility for the business of Government shall be effective during the absence from the Republic of the Honourable Kenas Aroi, M.P. Minister for Finance.

CONSTITUTION OF NAURU  
ASSIGNMENT OF RESPONSIBILITY FOR BUSINESS  
OF GOVERNMENT

IN EXERCISE of the powers in that behalf vested in His Excellency the President under Article 23 of the Constitution of Nauru, I, HAMMER DEROBURT, President of the Republic of Nauru, hereby assign to the Ministers of the Cabinet of Nauru, set out below, the responsibilities for the business of the Government of Nauru as set out opposite their names:-

MINISTERS OF CABINET

BUSINESS OF GOVERNMENT

Minister for Health and Education

The Portfolio of the President, Internal Affairs and the Public Service in relation to the business of Government to be undertaken in Nauru by the said Minister.

Minister for Finance

The Portfolio of the Minister for Island Development and Industry, the Minister for Works and Community Services and the Minister assisting the acting President in relation to the business of Government to be undertaken in Nauru by the said Minister.

Minister for Justice

The Portfolio of the External Affairs in relation to the business of Government to be undertaken in Nauru by the said Minister.

G.N. No. 366/1980 (Cont'd)

The assignment of business of Government of Nauru as set out above is in addition to and not in substitution for the business of Government of Nauru already assigned to the said Ministers. The above assignments of responsibility for the business of Government shall be effective during the absence from the Republic of His Excellency, President Hammer DeRoburt, O.B.E., M.P. and the Hon.R.B. Detudamo, M.P., Minister for Works and Community Services.
