THE CONSTITUTION OF NAURU
ASSIGNMENT OF RESPONSIBILITY
FOR BUSINESS OF GOVERNMENT
 (ARTICLE 23)

BY VIRTUE of the powers in that behalf vested in me under Article 23 of the Constitution of Nauru and of all other powers me enabling I, HAMMER DEROBURT, O.B.E., M.P.
