PUBLIC SERVICE ACT 1961-1979

(SECTION 75 AND 76 READ WITH SECTION 77)

DETERMINATION OF THE CHARGE OF

DISCIPLINARY OFFENCES

WHEREAS, pursuant to Section 73 of the Public Service Act 1961-1979, on 16th June 1981, Mr. Lisle Richardson Newby, Head of the Department of Health and Education, charged Mr. Andrew Heinrich of Yaren District, Nauru, with four disciplinary offences under Section 65(b) and (i) of the Act; and

WHEREAS, the said Mr. Heinrich was subsequently suspended from duty under Section 74 of the Act, until determination of the charge by the Chief Secretary:

NOW THEREFORE, I, TAMAITI WILLIE STAR, Chief Secretary, by virtue of the powers vested in me under Section 75 of the Act, and after considering reports relating to the disciplinary offences with which Mr. Heinrich was charge and the reply and explanation of Mr. Heinrich and all other relevant circumstances, am satisfied that Mr. Heinrich did commit the said disciplinary offences. I, accordingly, find him guilty of the said offences.

FURTHER, I, the said, TAMAITI WILLIE STAR, Chief Secretary, by virtue of the powers vested in me under Section 76 of the Act, do hereby dismiss the said Mr. Heinrich forthwith from the Public Service.

- Position : Liaison Officer
