> Adult \$4683 p.a.

> 20 Years of Age (90%) \$4215 p.a.

> 19 Years of Age (70%) \$3278 p.a.

> 18 Years of Age (80%) \$2810 p.a.

> 17 Years of Age (55%) \$2576 p.a.

> 16 Years of Age (50%) \$2342 p.a.
