### JUDGMENT

By consent, the determination of the Nauru Lands Committee in respect of the estate of the late Albert Dageago is to be amended to show -

- (a) the estate of Albert Dageago as possibly including a portion of coconut land in Buada District named Ianwiteibwiyeyiye but not yet identified or surveyed and in respect of which the ownership has not yet been determined; and

(b) if the estate includes that portion of land, the present owners of it are :-

Milka Eidubugitedu D. -

1/3 share of whatever interest the late Albert Dageago had in land.

Marina Ollson - a similar share.

Milka Eidubugitedu D. as trustee for

Marian Clodumar - a similar share.

This judgment is to be published in the Gazette and is to be conditional upon there being no objection to it lodged with the Registrar, Supreme Court, within 21 days of the publication of that issue of the Gazette. In the event of any such objection being lodged, this appeal is to be brought on again in this Court at its next sessions.
