REPUBLIC OF NAURU

CORPORATION ACT 1972

CORPORATION (PRESCRIBED FEES) (AMENDMENT)

REGULATIONS 1982

IN EXERCISE of the powers conferred on it by section 243 of the Corporation Act 1972, the Cabinet has made the following Regulations-

TITLE

1. These Regulations may be cited as the Corporation (Prescribed Fees) (Amendment) Regulations 1982.

THE PRINCIPAL REGULATIONS

2. In these Regulations "the principal Regulations" means the Corporation (Prescribed Fees) Regulations 1972.

AMENDMENT OF THE SCHEDULE TO THE PRINCIPAL REGULATIONS

3. The Schedule to the principal Regulations is amended -

(a) by adding thereto the following details of a new fee-

(i) in the first column of the said Schedule the number "7" ;

(ii) in the second column of the said Schedule the number "218" ;

(iii) in the third column of the said Schedule the words "On application for the name of a corporation to be restored to the register; and

(iv) in the fourth column of the said Schedule the symbol and number "\$100.00" ;

(b) by deleting from the first column of the said Schedule the numbers "7" and "8" now appearing therein and by inserting in lieu of them respectively the numbers "8" and "9"; and

(c) by deleting from the third column of the said Schedule the number "7" and by inserting in lieu of it the number "8".
