#### DEPARTMENT OF ISLAND DEVELOPMENT & INDUSTRY

(Directorate of Civil Aviation)

The Department of Civil Aviation has vacancies for four (4) AIR HOSTESSES and invites applications from young women who are willing to undergo training as Air Hostesses with a view to employment by Air Nauru.

#### Applicants must:

- (a) be eighteen (18) years of age and over
- (b) weight in proportion to height.
- (c) supply particulars of their educational standard and present or previous employment.

Members of the Public Service are eligible to apply.

Acceptance for training as an Air Hostess does not in itself mean that applicants will be appointed to the Public Service. Those who complete the course successfully will however be eligible for employment by Air Nauru, either on a permanent or temporary basis.

Training will be undertaken in Nauru, with exception of some particular procedures, which will be undertaken in Melbourne. While undergoing training in Australia, successful applicants will be provided with accommodiation and a subsistence allowance. On appointment as Air Hostesses after completion of training they will be paid commencing salaries as follows:

18 years of age : \$3384 per annum 19 years of age : \$3948 per annum 20 years of age : \$5076 per annum 21 years and over : \$5640 per annum




## DISTRICT OF EWA SCALE 1:50
