ELECTORAL ROLLS

The last General Election was held in December 1980 and because the law provides that the maximum life of a Parliament is three years, there will be a General Election on the 3rd day of December, 1983. The Electoral Rolls shall close in respect of every constituency at noon on the 12th day of November, 1983.

COPIES OF THE ROLLS

Electoral Rolls have been prepared for all Districts. Copies of these Rolls may be inspected at :-

- (i) Chief Secretary's Office
- (ii) Nauruan Affairs Office

Nauruan Citizens are asked to look at the Electoral Rolls and make sure if they are entitled to vote -

- (a) that their name appears on the roll of a District;
- (b) that that District is the correct District.

THE LAW

The Electoral Act provides -

1. If you are a Nauruan citizen and are 20 years old or more, you are entitled to have your name on the Electoral Roll of a District.
2. A Nauruan's name must not appear on the Electoral Roll of more than one District at a time.
3. You may not vote if your name does not appear on the Electoral Roll.
4. Your name cannot appear on the Roll of any District on which you are not entitled to have your name entered.
5. You are entitled but only if you are a Nauruan citizen of 20 years old or more) to have your name entered -

- (a) on the roll for the District in which you have been living for not less than one month, or, if you are living outside Nauru, on the roll for the District in which you were living for not less than one month immediately before you ceased living in Nauru;

O R

- (b) the roll for the District in respect of which you are registered as having been born in;

O R

- (c) the roll in respect of a District with which the Secretary of the Council has certified in accordance with Form 8 that you have a substantial connection by:-

- (i) Nauruan custom;
- (ii) by reason of the birth of either of your parents in that District;
- (iii) by reason of the registration for any electoral purpose of either of your parents in that District.

O R

- (d) any roll on which your name is already entered and has been so entered for not less than three years;

O R

- (e) the roll on which the name of your wife or husband if entered.

YOUR RESPONSIBILITY

It is up to you to apply for your name to be entered on the roll for the District you want - and on which the law as explained above allows your name to appear.

You must tell the Electoral Registrar if your name appears on a Roll on which it is not allowed to appear and ask for your name to be transferred to a Roll on which it may appear.

You may ask for your name to be transferred to a roll for another District on which it may appear (Example:

You live in Aiwo, and your name appears on the Aiwo Roll, it can stay there if you want. You might want to vote instead in Buada,

Where you are registered as having been born, and if so you can if you want to ask the Electoral Registrar to transfer your name to the Buada District Roll).

However, if you want to transfer your name from the Roll of the District in which you are living to another Roll, you will have to obtain the consent of a Council or of the District of the Roll for which your name now appears and the consent of a Councillor for the District of the Roll for which you wish your name to be transferred. If either of these consents is refused you can apply to the Council for consent, who can refuse consent. If the Council does not refuse consent within seven days, it is treated as having consented. If the Council refuses consent to the transfer, there are rights of appeal to the District Court.

The Electoral Registrar is Mr. Hamray Temaki, and his office is at the front of the Government Offices in the Chief Secretary's Department. Mr. Temaki will deal with any questions you may ask and can supply you with forms for registration or transfer of your name. Tell him if your name has been left off Rolls by mistake and go and see him if you wish to have your name transferred to the Roll of another District.

GENERAL ELECTIONS 1983

Intending Candidates for Election to membership of the Parliament of Nauru are advised:-

(a) That Nominations can validly be made only after the Rolls have been closed for each District (i.e. after Saturday 12th November, 1983) and on or before Nomination Day (i.e. on or before Saturday 19th November, 1983).

(b) Nomination Papers may be handed to the Returning Officer at Chief Secretary's Office during Public Service Office hours, Monday to Friday 14th November to 19th November, 1983 inclusive. To assist intending candidates, the Returning Officer will also be available in the Chief Secretary's Office between 8.00 a.m. and 1.00 p.m. on Saturday 19th November, 1983. Nominations will close at 1.00 p.m. on 19th November, 1983.

(c) Nominations must be in Form 6 of the Schedule to the Electoral Act 1965-1973 and signed by at least two Electors who are on the Roll for the Electoral District concerned (i.e. that in which the candidate intends to stand for election) and by the Candidate. The intending candidate must also be an Elector who is on the Roll for the Electoral District concerned.

(d) Nomination Forms are available from the Chief Secretary's Office.
