CONSTITUTION OF NAURU

ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT

IN EXERCISE of the powers in that behalf vested in His Excellency the President, under Article 23 of the Constitution of Nauru, I, BURARO DETUDAMO, being the Minister exercising the functions of His Excellency the President in Nauru under Article 21 of the Constitution of Nauru, hereby assign to the Ministers of the Cabinet of Nauru, as set out below the responsibilities of the business of the government of Nauru as set out opposite his name:

MINISTER OF CABINET

Minister for Health and Education

Minister for Justice

BUSINESS OF GOVERNMENT

The portfolio of the Minister for Finance, in relation to the business of government to be undertaken in Nauru by the said Minister.

The portfolio of the Minister for Island Development and Industry in relation to the business of government to be undertaken in Nauru by the said Minister.

The assignment of the business of the government of Nauru as set out above is in addition to and not in substitution for the business of the government of Nauru already assigned to the said Minister. The above assignment of responsibility for the business of government shall be effective during the absence from the Republic of His Excellency President Hammer DeRoburt, G.C.M.G., O.B.E., M.P. and the Honourable Kenas Aroi, M.P., Minister for Finance.
