- 1) to ensure that regular maintenance work is carried out on all airport ground support equipment, i.e. king loaders, towing tractors, trolleys, vehicles, etc. to ensure serviceability of same at all times to service Air Nauru aircraft's ground support requirements,
- 2) to ensure that all other plant and equipment to be used for maintenance work on the aerodrome are regularly maintained and are serviceable and effective,
- 3) co-ordinate and supervise the work of the labourers at the airport, and to ensure safe custody of airport plant and equipment,
- 4) attend to and/or liaise with Public Works Department and/or NPC for maintenance work such as:-
 - (a) electrical repairs both for runway lighting system as well as lighting system of all airport buildings,
 - (b) repair work to damaged runway lights, taxiway lights, apron floodlights, windsock lights, etc.
 - (c) removal and/or marking of temporary obstructions as notified.
 - (d) repairs to damages to airport buildings as notified,
 - (e) regular maintenance to standby generator,
 - (f) regular runway maintenance including painting runway identification markers, etc.
- 5) ensure that the grass around the airfield is regularly cut and that the airport grounds are cleaned and regularly maintained,
- 6) ensure that aircrafts are safely towed to their parking slots as and when required,
- 7) any other works as may from time to time be directed by the Director of Civil Aviation.

Qualifications: A mature and reliable person who is able to lead is required with a minimum of 5 years work experience in the areas of work described.
A general working knowledge of heavy duty working equipment of the type described is desirable.

Duties: Responsible to Project Officer:

- 1) Maintain all office records that are kept at Airport Office and ensure that all records such as passenger manifests that are received in this office for statistical requirements are in fact regularly received.
- 2) Prepare accurate monthly traffic statistics for submission to the various aeronautical authorities that require such statistics from the records received as in (1) above.
- 3) Initiate purchase orders for aircraft inflight service stores requirements such as beer, hard liquor miniatures, wines, cigarettes, matches, toiletries etc and maintain accurate stock records for such purposes, ensure stocks are always available.
- 4) Receives, checks and banks aircraft bar sales monies and maintain accurate records of bar sales on each flight.
- 5) Initiate purchase orders for inflight magazines, newspapers and periodicals.
- 6) Ensure that the attendance book for airport staff are duly signed by all concerned and that time and variation sheets are accurately checked and variations noted.
