PUBLIC SERVICE ACT 1961 - 1979

SECTION 27(2) - NAURUAN BASIC WAGE

IN EXERCISE of the powers vested in me under Section 27(2) of the Public Service Act 1961 - 1979, I, BURARO DETUDAMO, Minister responsible for the Public Service, HEREBY ADVISE THAT the reviews have been carried out on the Retail Price Index of Commodities and HEREBY DETERMINE that the following basic wage rates shall take effect from the 19th November 1984, which is the first local payperiod following the 15th November 1984.

Adult	-	\$5509 p.a.
20 years of age (90%)	-	\$4958 p.a.
19 years of age (70%)	-	\$3856 p.a.
18 years of age (60%)	-	\$3305 p.a.
17 years of age (55%)	-	\$3030 p.a.
16 years of age (50%)	-	\$2755 p.a.
