Duties: To initiate subject matters for the Annual Philatelic programme, assemble all preliminary details such as physical art work and photographic media for each release; control and monitor all aspects of production till final distribution of stamps, review outstanding orders; correspond with Philatelic agencies abroad; carry out other duties as may be required by the Secretary for Finance.

As Head of Philatelic Bureau he will be responsible for Bureau's administration, custody and security of stamp stocks.

Qualifications: It is a challenging job. Should have a deep knowledge in philately, long experience in development of thematic subjects and capacity to handle correspondence with thousands of stamp collectors.
