## SUPERANNUATION ACT 1966-1973 (SECTION 7)

### APPOINTMENT OF MEMBERS AND CHAIRMAN OF SUPERANNUATION BOARD

It is notified for general information that the Cabinet, in exercise of its powers under Section 7 of the Superannuation Act 1966-73, with immediate effect,

- (vi) stipulated that the above appointments and re-appointment be effective for a period of three years.
