MOTOR TRAFFIC ACT 1937 - 1973

ROAD TRAFFIC SIGNS

BY VIRTUE of the powers in that behalf vested in me by Section 43(1) of the Motor Traffic Act 1937 - 1973, I, KENAS AROI, Acting President of the Republic of Nauru, HEREBY SPECIFY the design and meaning of the following traffic control signs:

PEDESTRIAN, CROSSING SIGN (AIWO PRIMARY SCHOOL)
OPPOSITE THE SCHOOL'S MAIN GATE

Consisting of 4 white lines to be painted on the road,

Middle two lines for the full length of the road.

Side two lines on each outer side for half the length separated by 2.4 meters.

A sign-post on each side on the curb, showing against yellow background the symbol of children crossing, 2.25 meter long to the centre of the .6 meter square post.

A flag post on either side of the curb 1.5 meter long painted with alternate bands of red & white with a sign board .45 meter removable square red flag, with 'CHILDREN CROSSING' written on it in white letters.

The removable flags will indicate that drivers must stop short of the crossing if pedestrians are standing on the curb, with the intent to walk.
