SUPREME COURT LAND APPEAL No. 6 OF 1985

IDARABWE IKA V NAURU LANDS COMMITTEE & ORS

The Estate of IKA DITTO DECEASED determination of beneficiaries dated 27th November 1985 published in Gazette No. 436 and 437 of 1985.

Consequently, I find that there is not sufficient evidence to rebut the presumption that the deceased did not intend to disinherit his legitimate son, the appellant.

The effect of this finding is that the appeal is allowed and a declaration made that the decision of the respondent, the Nauru Lands Committee in Gazette No. 437 of 1985 is to be amended by including the appellant as a beneficiary in the estate of the late Ika Ditto deceased in respect of all lands other than the land ATARORO being portion No. 21 in the Ijuw District. This will result in the shares of the respective beneficiaries being adjusted accordingly. "
