NOTIFICATION OF WRIT FOR ELECTION

ELECTORAL ACT 1965 - 1973

NOMINATIONS

GENERAL ELECTIONS 1986

Intending Candidates for Election to membership of the Parliament of Nauru are advised:-

(a) That Nominations can validly be made only after the Rolls have been closed for each District (i.e. after Saturday 15th November 1986) and on or before Nomination Day (i.e. on or before Saturday 22nd November 1986).

(b) Nomination papers may be handed to the Returning Officer at Chief Secretary's Office during Public Service hours, Monday 17th November to Saturday 22nd November 1986 inclusive. To assist intending candidates, the Returning Officer will also be available in the Chief Secretary's Office between 8.00 a.m. and 1.00 p.m. on Saturday 22nd November, 1986. Nomination will close at 1.00 p.m. on 22nd November, 1986.

(c) Nominations must be in Form 6 of the Schedule to the Electoral Act 1965-1973 and signed by at least two Electors who are on the Roll for the Electoral District concerned (i.e. that in which the candidate intends to stand for election) and by the Candidate. The intending candidate must also be an Elector who is on the Roll for the Electoral District concerned.

(d) Nominations Forms are available from the Chief Secretary's Office.

(e) Candidates who have been duly nominated, and wish to withdraw their candidature may do so by notice in writing signed by them to the Returning Officer not later than 29th November, 1986.

NOTIFICATION OF DATES OF NOMINATION

As required by Section 15(2) of the Electoral Act 1965-1973,
I NOTIFY :

- (a) That by virtue of Section 10 of the Electoral Act 1965-1973, the rolls shall close in respect of every constituency in the Republic of Nauru at noon on the 15th day of November, 1986;
- (b) That by virtue of Section 16 of the Electoral Act 1965-1973, nominations of candidates for election as a member of any constituency in the Republic of Nauru shall be accepted not later than noon on the 22nd day of November 1986.

The electoral rolls may be inspected at the Office of the Chief Secretary, Government Buildings, Yaren District, during normal office hours.
