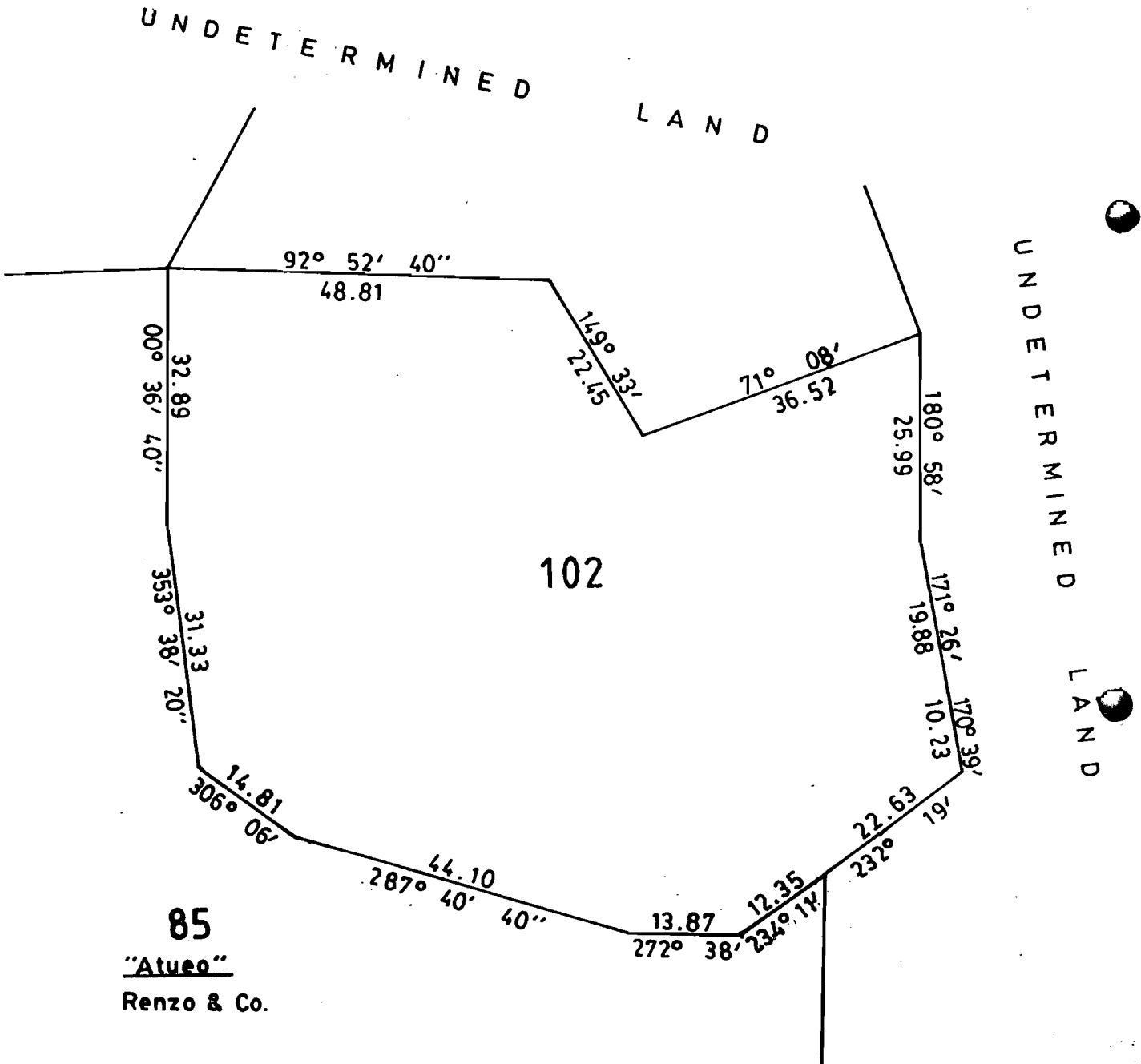
Those who disagree with the above determination may appeal to the Supreme Court Registry within 21 days.

Scale 1:750

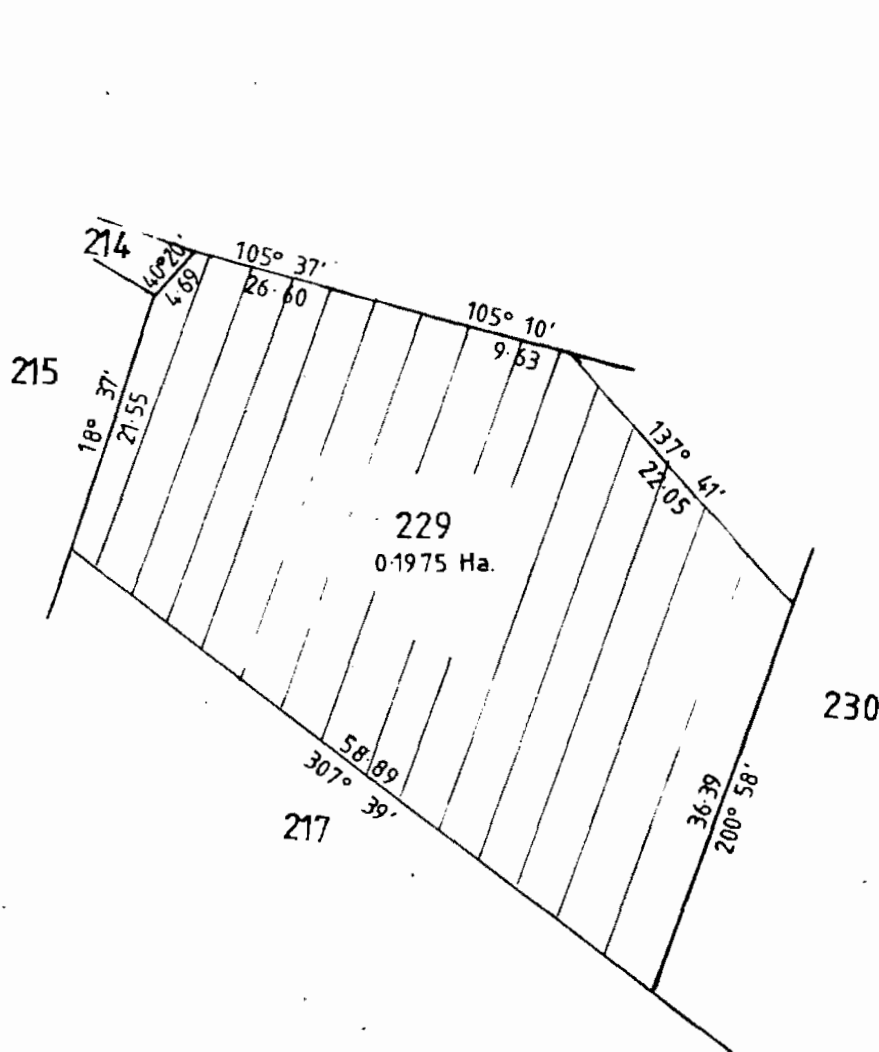
