SECTION 3 (1)

DESIGNATION OF TUVALU AS RECIPROCATING COUNTRY

It is notified for general information that pursuant to section 3, subsection (1) of the Maintenance Orders (Reciprocal Enforcement) Act 1973, the Cabinet has, at its meeting of 28th November 1986, designated Tuvalu as a Reciprocating Country within the meaning of the said Act, provided that the Government of Tuvalu also, on the principle of reciprocity, designates the Republic of Nauru to be a Reciprocating Country under its law relating to Reciprocal Enforcement of Maintenance Orders.
